IMPORTANT NOTICE - PLEASE READ

As you are all aware Panthers have recarpeted the Expo Pavillion and we will all agree it is certainly an improvement, the recarpeting has caused a change to certain procedures in the venue.

1. No longer can vehicles drive into the venue further than the area covered with tarps - please respect this directive from Panthers.
2. **Many of the power access boxes have been carpeted over therefore minimising the availability of power in the venue. No cords can be laid on top of the carpet and taped down as this contravenes the clauses in our public liability policy and is against the directive of Panthers management.**
3. **No subletting of tables allowed - all names must appear on the booking slip.**

Therefore because of the limited power access, each exhibitor carefully question their own needs for power and take on board the following:

- a. Laptops, Mobile Phones and credit card mobile machine can be recharged overnight.
- b. Pricelists that are kept on laptops can be printed into a paper document for the show.
- c. Acquisitions and disposals can be updated onto a laptop from your invoice book at night.
- d. Paper receipts can be given instead of using machines.
- e. LED lights - that run on batteries - can be used for your display.

As you are all aware we have introduced extra lighting into the venue and of course this requires a greater use of power - the canteen uses power - the security scanning machine requires power - the air conditioning requires power. There is a limit to the amount of power that is able to be used in the venue without incurring extra charges (this is already happening with the air conditioning) - we ask that you all reexamine your power requirements as **many of you will not be able to be given access to power** due to circumstances beyond our control.
